

This reference booklet is provided as a quick reminder about basic system functions of the Kurzweil 4000. Consult the Operator's Guides included with the system for more detailed information.

System Start-Up

Procedure:

 Press the POWER switch located on the front of the scanner unit to provide power to the Kurzweil system.



- Press the terminal POWER switch (located on the front of the CRT housing) to the On position.
- The letter "O" will be displayed, followed by a blinking exclamation point (!). This indicates that the system self-test is in progress. Self-test takes approximately 30-45 seconds to complete.
- When self-test is complete, the Status Prompt will be presented (OKI).

NOTE

If the Status Prompt is not displayed after one minute, press RESET.



- 5. The operator may now:
 - Login to the processing system, or
 - · Install a new or existing software release.

Login Procedure

Procedure:

 Press the letter "D" in response to the Status Prompt. The Login Menu will be displayed.

NOTE

If the Login Menu is not displayed, follow the Software Installation Procedure, described below.

- Enter the date (as MM/DD/YY) and time. Any nonalphanumeric character may be used to separate the fields in the time and date entries.
- Enter the operator name (or initials). This information is optional. If provided, it will be placed into KDEMLOG, a special record-keeping file that lists jobs and operators.
- 4. Press ACCEPT to enter the Login Menu information.

Software Installation Procedure

Procedure:

- Press RESET.
- When the Status Prompt (OK!) is displayed, insert Volume 1 of the Software Release set in the disk drive (label to the right) and close the door securely.
- 2. Press "F".
- 3. Enter the date (as MM/DD/YY) and time.
- 4. Two options are presented next. Type either:

"I" to install a release, or

"R" to rebuild a software base on the system.

WARNING

- All data on the disk will be destroyed in a rebuild operation.
- Either process takes a few minutes. After the installation or rebuilding process, the TOP Level Dispatch Menu will be displayed.

Scanning Parameters

To access the Scanning System, type the number one (1) followed by ACCEPT, in response to the "ENTER CALL-UP NUMBER:" prompt in the Top Level Menu.

Entry Question Menu

The Entry Question Menu will be displayed if a document has been scanned, but not displayed on the terminal screen. Otherwise, the New Job Menu is presented.

Procedure:

- Determine whether the previously scanned (but unedited) text in the input buffer is to be saved or deleted.
 If the text is to be deleted, type Y (Yes). The text will be
- deleted automatically and the New Job Menu will be displayed.
- If the text in the input buffer is to be saved, type N (No).
 The New Job Menu will be displayed.

New Job Menu

This menu allows the user to start a new file, or to append to a file that already exists on the system.

Procedure:

- Select option number 1. Supply a Document Name. If "Name" exists, the file will be appended to.
- Select option number 2. This is a toggled variable and either New or Old must be selected. If Old is selected, text will be appended to.
- Press the ACCEPT key. If no errors are discovered (e.g., selecting Old when the filename does not exist) the operator is presented with the Document Entry Menu.
- 4. Press the CANCEL key to redisplay the TOP Level Dispatch Menu.

Document Entry Menu

This menu sets the framework for scanning operations.

Procedure:

- Select option number 1. Training Set Name refers to the name of an exisiting training set. If the job is New, leave the setting at None.
- Select option number 2. Training Mode may be Off, Manual or Automatic. The default mode is Automatic, unless a training set is loaded.
 - Select option number 3. The User Page Number is supplied by the operator and issued to number pages in the editor.
 Select option number 4. The Lexicon is an internal
- dictionary that is used as an aid in the identification of characters from context. Select additional dictionaries by using option number 4.

 5. Select options 5 and 6. These options will cause underlines and super/subscripts to be marked for output
- to a word processor or typesetter.

 6. Press ACCEPT. The Text Ambiguity Menu is displayed.

NOTE

If an old training set has been requested, the operator is immediately presented with the editing subsystem and scanning may commence.

Text Ambiguity Menu

Text Ambiguity Menu items are toggled. Press the associated number key until either Yes or No is displayed.

Procedure:

- Select option number 1. Indicate whether Ones and small L's are alike by displaying Yes or No.
 Select option number 2. Indicate whether capital I's and
- small L's are alike by displaying Yes or No.
- Select option number 3. Indicate whether Zeros and capital O's are alike by displaying Yes or No.

Training and Production Procedure

Procedures:

- Position the paper approximately one inch from the top
 of the glass on the right hand side and one inch from the
 edge of the scanner. If an Automatic Document Feeder
 is not present, cover the page with the rubber platen
 mat.
- Instruct the 4000 to scan the first page by pressing (SHIFT) SCAN PAGE. The scanner will search for the first line of text.
- Press ACCEPT and a page boundary marker will appear on the screen. These boundaries appear after a SCAN PAGE command. They are useful for distinguishing the start of one page from the end of another.
- Press ACCEPT again and the first line of text will be displayed. Check all the interventions during training to verify that the "guesses" are correct. If necessary, correct the images, as described below.
- Continue to move through the line using the SHOW (right arrow) key. Correct all wrong guesses, touching images and broken characters (procedures listed below). When the end of the line is reached, press ACCEPT.

Commands that control scroll modes are listed in the *Operator's Manual*. Refer to section 3.1 for complete information about the display of text on the terminal screen.

Training Modes

Refer to the *Operator's Guide* (section 3.1) for more detailed information regarding Training Modes. The procedure described below assumes the use of *Manual* mode.

Procedure:

- Position the cursor under the first interventioned character by using the SHOW (right arrow) key.
- If the image is clear and well formed and the system's "guess" is incorrect, correct the guess by typing the letter that matches the image.
- If the image is clear and well formed and the guess is correct, press SHOW (right arrow) to move to the next intervention and repeat steps 1 and 2. Characters displayed in inverse video must be;

Corrected, when the guess is incorrect.

Accepted, when the recognition is correct.

Deleted, if the image is not clear.

 After all the characters displayed in inverse video have been reviewed, press ACCEPT to approve the line for training.

Special Features

Bad Images

The BAD IMAGE key is used when non-interventioned characters are displayed incorrectly. It is effective in *Manual* Training Mode, only.

Procedure:

- 1. Position the cursor underneath the incorrect character.
- Press BAD IMAGE. The Multiple Property Descriptor (MPD) that was most closely associated with the incorrect image will be deleted. A message prompt informs the user that the:

MPD will be deleted.

- 3. Change the incorrect character.
- 4. Continue to train by pressing SHOW (right arrow).

NOTE

If the image of a character cannot be displayed, it is necessary to delete the MPD for that character. Refer to Chapter Four of the *Operator's Guide* for complete information about Advanced Operations.

Touching Characters

If the display shows joined characters typical of the font, put the intervention between braces as described below.

Procedure:

- Press JOIN IMAGE. A pair of braces will enclose the character that the cursor is below.
- 2. Type in the correct characters.

For example:

eve ~ time the symbol occurs
eve {ry} time the symbol occurs

Special Symbols

If a graphic character is encountered in the text and there is no keyboard equivalent, the JOIN IMAGE braces allow the operator to substitute a different character string. A maximium of 3 characters is allowed.

Procedure:

- Press JOIN IMAGE. A pair of braces will enclose the character that the cursor is below.
- 2. Type in a substitute character string.

For example:

Snap, crackle, pop - Rice Krispies™ Snap, crackle, pop - Rice Krispies {@@}

Broken Characters

If broken characters are encountered, follow the procedure described below.

Procedure:

- Position the cursor at the first part of the broken image and press JOIN IMAGE.
- It may be necessary to press JOIN IMAGE more than once, to surround the broken characters. Press SHOW to redisplay the stire image.

WARNING

The JOIN IMAGE key must be used to enter braces for the applications associated with touching characters, broken characters and special symbols. Do not enter braces from the keyboard.

Train Image

TRAIN IMAGE adds a new image to the Training Set while in Training Mode Off.

Procedure:

- Press SHOW in Training Mode Off. If the image is of good quality but the interventioned guess is incorrect, change the interventioned character.
- 2. Press TRAIN IMAGE.
- 3. The message, TRAINING TURNED ON will appear.

NOTE

In the DOCUMENT DISPOSITION MENU be sure to Save the training set.

Font Identification

The Kurzweil system can be configured to preserve, or "flag" changes in typestyle.

Procedure:

- Position the cursor under the first character where the font change occurs.
- 2. Press BEGIN FONT. A prompt will instruct the user to:

Please enter a font number (1 - 9)

"< N" will appear before the first character.

NOTE

"N" is the user-supplied font number.

- Train on all the characters in the new font that are interventioned, by using the SHOW (right arrow) key.
- At the end of the font change, position the cursor after the last character and press END FONT and provide the same font number. "> N" will appear after the last character.
- Repeat this procedure and assign new fonts a different identification number. If there are additional characters in the line, train on them; then ACCEPT the line for training.

If the system places the angle brackets in the wrong place during training, delete them and insert the brackets in the correct position using the procedure above.

Underline and Super/Subscript Identification

Follow the procedure below to train the system on underlines or script characters that have not been flagged properly.

Procedure:

- Position the cursor under the first character where the text change occurs.
- 2. Press Begin Underline (or Begin Sub/Superscript).
- 3. At the end of the text change, position the cursor after the last character and press End Underline (or End Sub/Superscript).

End Job Procedure

Procedure:

 When scanning activities are complete, press the END JOB key. The Exit Question Menu will be displayed, if there is scanned, but unscrolled text in the input buffer.

2. The operator may:

Delete the scanned text (press Y and press ACCEPT). The New Job Menu will be displayed. Return to the editor and scan additional text (press CANCEL).

Preserve the scanned text or training (press N and ACCEPT). The End Job Menu will be displayed.

When the END JOB key is pressed and text has been edited or training has been performed, the End Job Menu is displayed.

Determine whether text is to be deleted, saved, or autooutput.

 If additional training was performed (with the TRAIN IMAGE key) the images may be saved and added to existing training. Select Yes to incorporate additional training.

The Training Set Name is required (and operator-supplied) if Save Training is specified. ACCEPT returns control to the New Job Menu. To exit from the Scanning Subsystem, press CANCEL.

System Backups

System Backups are performed to provide insurance against inadvertent deletions and System Errors.

Procedure:

- Select Utilities (option 4) from the TOP Level Dispatch Menu. The Utilities Dispatch Menu will be presented.
- Select Backup/Restore (option 1) from the Utilities Dispatch Menu. The Backup/Restore Dispatch Menu will be displayed next.
- Select option 1 (Backup Files to a Floppy). The Backup Menu will be presented.
- Select option 1. Indicate which type of backup to perform (Full or Incremental).
- 5. Select option 2. Enable or disable the file check option.
- Select options 3-7, one at a time. Press the associated option number until "Backup" or "Don't Backup" is displayed.

- Select option 8. If an Incremental backup is desired, enter the date from which files are to be copied. When all options have been selected, press ACCEPT.
- Provide a descriptive name for the backup set and place a floppy disk in the disk drive.
- . Press ACCEPT to start the Backup operation.
- When the backup function is complete, press ACCEPT.
 The TOP Level Dispatch Menu will be presented.

Restore Procedure

Files that were copied to a Backup or Library floppy disk can be reinstalled on the Kurzweil system by performing a Restore operation.

Procedure:

- Select Utilities (option 4) from the TOP Level Dispatch Menu. The Utilities Dispatch Menu will be presented.
- Select Backup/Restore (option 1) from the Utilities Dispatch Menu. The Backup/Restore Dispatch Menu will be displayed next.
- Select option 2 (Restore Files from a Floppy). Insert Volume 1 of the backup floppy set and press ACCEPT. Files that do not conflict will automatically be restored to the 4000 system. When file names conflict, the operator is given the opportunity to overwrite the Winchester version.

WARNING

Ensure that the Winchester file is no longer required. If overwritten, it cannot be recovered.

 When the operation is complete, remove the floppy disk from the disk drive.

If additional backup disks complete the set, they will have to be installed, also.

List Files Procedure (for Backup Floppy Disks)

Procedure:

- Select Utilities (option 4) from the TOP Level Dispatch Menu. The Utilities Dispatch Menu will be presented.
- Select Backup/Restore (option 1) from the Utilities Dispatch Menu. The Backup/Restore Dispatch Menu will be displayed next.
- Select option 3 (List Files That Were Backed Up to a Floppy).

A message will be displayed, instructing the user to:

Mount Volume 1 of the backup floppy.

and

Press the Accept key to continue.

4. Press ACCEPT to display the TOP Level Menu.

Library Floppy Disks

Library floppy disks are created so that users may copy specific files or groups of files as part of an archival storage system. The configured disk is used as part of *Filing Operations*, described below.

Procedure (Creation):

- Select Utilities (option 4) from the TOP Level Dispatch Menu. The Utilities Dispatch Menu will be presented.
- 2. Select (option 2) from the Utilities Dispatch Menu (Create a Library Floppy).
- Enter a title or description for the floppy.
- Insert a ("writeable") floppy disk into the drive and press ACCEPT.

System Error Procedures



Occasionally, the 4000 may experience a System Error. Follow the procedures below to create and use a System Error floppy disk. Forward the disk to Kurzweil for diagnosis by the Technical Support staff.

Procedure (Create a System Error disk):

- Select the Utilities option from the TOP Level Dispatch Menu. The Utilities Dispatch Menu is displayed next.
- 2. Select option 4 (Create a System Error Floppy).
- Insert a ("writeable") floppy disk into the drive and press ACCEPT.

The configured System Error disk may be used in the event of a System Error, according to the instructions below.

Procedure (Use a System Error disk):

When a System Error occurs:

- 1. Press RESET.
- Insert a configured System Error floppy disk into the disk drive.
- 3. When the status prompt is displayed (OKI), press the letter "F".
- Enter the date and time in response to the displayed questions.
- Press the ACCEPT key to recover diagnostic information to the floppy disk.

The System Error floppy disk must be forwarded (in a padded mail envelope) to:

Filing Operations

To access the Filing subsystem from the TOP Level Dispatch Menu select option 3 (Filing) and press ACCEPT.

Copying Files

Procedure:

To duplicate a file on the Kurzweil system:

- Select option 1 from the Filing Dispatch Menu (Copy a File). The Copy a File Menu is used to duplicate files, convert a document to smaller segments or append the contents of one document to another.
- Select the File Type, by pressing option 1, which will present the available options. "Toggle" through the options by pressing 1, repeatedly.
- Select option 2. Enter the name of the file that is to be copied. If the file resides on floppy disk, precede the filename with FLPY:.
- Select option 3. Enter the name of the file to be created.
 Use this option to copy files to a library disk. Select option 3 and precede the filename with FLPY:.
- Select option 4. Enter the number of pages to be skipped. This option may be changed only if the File Type selected is Document. If the entire document is to be copied, leave the setting at 0.

NOTE

This option allows a document to be converted to smaller sections. Refer to the System Administration Guide for complete details.

- Select option 5. Enter the number of pages that are to be copied. If the entire document must be copied, leave the (default) setting at 10,000.
- Press ACCEPT. When the copy action is finished, the following message will be displayed:

Copy successfully completed.

Press Cancel, or enter any other key to continue.

Deleting Files

Procedure:

- Select option 2 from the Filing Dispatch Menu (Delete a File). The File Deletion Menu will be displayed.
- Select the File Type, by pressing option 1, which will present the available options.
- Indicate the name of the file that is to be deleted from the Kurzweil 4000 system. Preface the filename with FLPY:, if the file is on a floppy disk.

Typing Out Files

Procedure:

 Select option 3 from the Filing Dispatch Menu. A message will be displayed that asks the operator to:

Enter the name of the document to be typed out.

If the file resides on a floppy disk, precede the filename request with FLPY: After the text has been displayed, a final message informs the user that the

End of text

has been reached, and

Enter Cancel to go back or any other key to continue.

Reediting Files

Procedure:

- Select the Filing option (3) from the TOP Level Dispatch Menu and option 4 (Reedit A File) from the Filing Dispatch Menu, when it is displayed.
- A prompt will instruct the user to:

Enter the name of the document to be reedited.

Press ACCEPT. Another question is presented to the operator

^{***}Text will be copied to the KDEM unedited text file
***Are you continuing with a previous reedit? (Y/N):

- 3. Answer No (N) and press ACCEPT. If the file is too large for the unedited text buffer, the operation will have to be performed again, after editing. Refer to the System Administration Guide for complete details.
- Cancel Filing operations and select Scanning (option 1)
 from the TOP Level Dispatch Menu. The operator
 will be informed that

There is unedited scanned text in the KDEM input buffer.

Do you want to delete it? (Y/N):

- Answer No (N) to this question and press ACCEPT.
 The New Job Menu will be displayed next.
- 6. Change the Document Name and press ACCEPT. Press ACCEPT as both the Document Entry Menu and the Text Ambiguity Menu are displayed. A prompt instructs the user to:

Place page on scanner, press SCAN PAGE and ACCEPT to start job.

 Press ACCEPT. Text can be displayed one line at a time by pressing ACCEPT, or text may be scrolled continuously by pressing one of the SCROLL keys.

Refer to the System Administration Guide for specific details about reediting text.

Magnetic Tape Drive Operation

Procedure:

- Press the POWER switch at the top of the tape drive operating panel. The light indicates that the system is On.
- Mount a tape (with a write-enable ring installed), following the arrows that show the correct tape path. When the tape drive is write-enabled, the light on the WRT EN button is On.
- 3. When the tape has been threaded, press LOAD and the mechanical arms will swing into place.
- Press LOAD again and the drive will search forward for the beginning-of-tape marker.
- Select the proper tape density (either 800 or 1600 bpi).
 If the HI DEN button is illuminated, the drive is configured for 1600 bpi. Otherwise, 800 bpi is standard.
- When the light on the LOAD button goes on, press ON-LINE to enable the communications link between the tape drive and the Kurzweil 4000.

After copying to (or from) tape:

- 1. Press ON LINE -- the light will go out.
- Press REWIND -- the tape will rewind to the load position.
- Press REWIND again -- the tape will rewind off the top reel.

Automatic Document Feeder (ADF) Operation

Procedure:

- Place the platen cover down, so that it rests on the glass scanner surface. The ADF is now enabled.
- 2. Up to 25 pages may be placed in the paper hopper at the back of the unit. Jog the pages so that the edges align and place them in the hopper face down, with the tops of the pages toward the switch panel. Adjust the guide rails as required.
- When SCAN PAGE is pressed, pages will be fed to the scanner surface, automatically. Processed pages are deposited in the paper reservoir.

To disable the ADF and perform scanning operations manually, raise the platen cover to its upright position.

Power Down Sequence

Follow the instructions below to turn the Kurzweil system off.

Procedure:

- Select the Log out option from the TOP Level Dispatch Menu (option 6).
- 2. The following message will be displayed:

"You may now shut down the system, or enter any character to Login again.

Enter cancel to go back, or enter any other key to continue."

If a system shut down is desired, simply push the POWER button to the Off position.

WARNING

Log out procedures must be followed to shut down the system safely.
